Why take care of hearing loss?

Untreated hearing loss can also lead to social isolation, cognitive decline and dementia, and a recent study¹ shows that hearing loss is the biggest modifiable factor that can influence the development of dementia.

In Denmark, it is estimated that more than 800,000 people live with a hearing loss.
