## 1. Notification by BlackRock Inc. of 7 January 2025

### 1.1. Summary of the notification

Vastned NV has received on 10 January 2025 a corrigendum of a transparency notification dated 7 January 2025, which indicates that BlackRock Inc., as a result of the acquisition of shares following the completion of the reverse cross-border legal merger in which Vastned Retail N.V. was merged with and into Vastned NV on 1 January 2025 at 00.00 CET, holds 3.39% of the voting rights of Vastned NV. BlackRock Inc. has thus exceeded the 3% shareholding threshold.
