NewCap Holding A/S' notering på Nasdaq Copenhagen og fjernelse fra observationsliste / NewCap Holding A/S' listing on Nasdaq Copenhagen and removal from observation list

NewCap Holding A/S har i dag modtaget meddelelse fra Nasdaq Copenhagen, at denne har godkendt NewCap Holding A/S's fortsatte børsnotering og samtidig fjerner NewCap Holding A/S fra Nasdaq Copenhagens observationsliste.

Baggrunden for meddelelsen er den identitetsændring af NewCap Holding A/S som fulgte efter NewCap Holding A/S erhvervelse ultimo 2025 af aktiviteterne i NCI Advisory A/S og har omfattet, at NewCap Holding A/S opfylder betingelserne i Nasdaqs regler.

Vi er stolte af at videreudvikle NewCap Holding A/S som en børsnoteret nordisk platform for kapitalforvaltning og relaterede tjenester. Med NCI Advisory A/S og Observatum Compliance ApS er vi godt positioneret til at støtte investeringsteams i et stadig mere komplekst markedsmiljø og forfølge fremtidige vækstmuligheder," siger Jørgen Beuchert, administrerende direktør, NewCap Holding A/S.

NewCap Holding har siden overtagelsen ultimo 2025 styrket sine aktiviteter indenfor asset management gennem de alternative investeringsfonde Nordic Corporate Investments A/S og NCI Credit Opportunity Fund A/S. Gennem erhvervelsen af Observatum Compliance ApS, der leverer services inden for områder som compliance, risikostyring, rapportering m.v. er der skabt en platform for servicering af kapitalforvaltere, der kan håndtere alle funktionelle områder, som kapitalforvaltere skal kontrollere, herunder overholdelse af alle lovkrav og regler, som løbende bliver strengere. Hermed har NewCap Holding A/S skabt en platform, hvor investeringsteams kan fokusere på at optimere investeringsstrategier og afkast.

De alternative investeringsfonde Nordic Corporate Investments A/S og NCI Credit Opportunity Fund A/S, der forvaltes af NCI Advisory A/S, har siden starten genereret et gennemsnitligt afkast på mere end 10% til aktionærene, og i løbet af de seneste fem år har afkastet i Nordic Corporate Investments A/S oversteget 15% om året.

NewCap Holding A/S has today received notification from Nasdaq Copenhagen that it has approved NewCap Holding A/S's continued listing and at the same time removed NewCap Holding A/S from Nasdaq Copenhagen's observation list.

The background to the announcement is the change in identity of NewCap Holding A/S that followed NewCap Holding A/S's acquisition at the end of 2025 of the activities of NCI Advisory A/S and has included that NewCap Holding A/S meets the conditions in Nasdaq's rules.

We are proud to further develop NewCap Holding A/S as a listed Nordic platform for asset management and related services. With NCI Advisory A/S and Observatum ApS, we are well positioned to support investment teams in an increasingly complex market environment and pursue future growth opportunities," says Jørgen Beuchert, CEO, NewCap Holding A/S.

Since the acquisition at the end of 2025, NewCap Holding has strengthened its activities within asset management through the alternative investment funds Nordic Corporate Investments A/S and NCI Credit Opportunity Fund A/S. Through the acquisition of Observatum Compliance ApS, which provides services in areas such as compliance, risk management, reporting, etc., a platform has been created for servicing asset managers that can handle all functional areas that asset managers must control, including compliance with all legal requirements and regulations, which are continuously becoming stricter. In this way, NewCap Holding A/S has created a platform where investment teams can focus on optimizing investment strategies and returns.

The alternative investment funds Nordic Corporate Investments A/S and NCI Credit Opportunity Fund A/S, managed by NCI Advisory A/S, have since its inception generated an average return of more than 10% to shareholders, and over the past five years, the return in Nordic Corporate Investments A/S has exceeded 15% per year.
