Announcement of Early Close of Offer Period.

Valuer has applied for admission to trading on Nasdaq First North Premier Growth Market Denmark.

Terms and conditions in the Prospectus (section 18.4)(Company Announcement No. 1-2021) specify that the offer period runs from 2 – 15 February 2021 with early close available from 10 February 2021 at 23:59 CET.

Valuer has attracted investor interest not only from Danish but also from significant international investors and has been oversubscribed quickly. The Board of Directors have decided that the offer period will be closed early on 12 February at 23:59 CET to ensure the participating investors will receive decent allocations.
