Companies in these, and more, sectors need to comply with the directive as from 18 October 2024.

Founder and CEO, Lars Nybro Munksgaard, says:

"The release of our NIS2 compliance solution is part of RISMAs commitment to provide our customers with governance solutions for compliance with a multitude of legal frameworks.
