China makes up around half of the global market for point-of-use water purifiers where Philips Water Solutions is the market leader with a great number of purifiers sold annually.

Chief Executive Officer at AquaShield, Alex Rishoej, says: "Aquaporin delivers on both innovation, quality, and market differentiation with their technology. Gaining momentum on the Chinese market is a tough nut to crack, but with Aquaporin we see huge potential in their unique technology and how it is rooted in the way nature filters water".

Philips Water Solutions and Aquaporin estimate that more than 140,000 households had a Philips Water Solutions purifier powered by Aquaporin Inside[®] at the end of 2022. This number is expected to largely increase by the end of 2023.

This partnership framework agreement does not change the previously announced financial guidance for the financial year ending December 31, 2022.
